You understand that vendors will be selected and retained by the wedding planner and you have no say in the interest thereof, and those selected vendors and venues referenced herein are subject to change without notification and no breach shall be made or damages collected. You agree and understand that while participating in this elegant elopement extravaganza while on the capital state house grounds throwing of confetti, candy, or any other materials are prohibited with absolutely no exceptions and violators will immediately be removed.

Price and Payment Terms

You will pay a total price of \$2,000 to include products and services needed to plan the event and must be paid in full at the time of registration.

Cancellation/Refunds

You agree and understand that in the event of a cancellation by Victoria Marie Wedding Planners and Designers for lack of required participation, a full refund will be issued to all those registered. You also agree and understand that in the event of cancellation or lack of performance by you, a \$500 cancellation damage fee will be retained from date of registration to 30 days prior to event. 50% cancellation damages will be retained should you cancel 29 days prior to the event.
